6 I, Peter A. Brandt, hereby declare as follows:

7 1. I am a member of the State Bar of California and I am admitted to practice before  
8 the United States District Court for the Eastern District of California. I am an attorney for  
9 Proposed Defendant Intervenor The Humane Society of the United States (“HSUS”) in the above-  
10 captioned matter. I submit this declaration in support of HSUS’s Notice of Motion and Motion to  
11 Intervene and Proposed Motion to Dismiss for Lack of Subject Matter Jurisdiction and Failure to  
12 State a Claim.

13 2. I am over the age of 18 and have personal knowledge of the matters set forth  
14 herein and, if called upon, I could and would competently testify thereto.

15 3. On February 4, 2014 I learned that Missouri Attorney General Chris Koster and  
16 the State of Missouri had filed suit in this Court on February 3, 2014 against California’s  
17 Attorney General challenging the constitutionality of California state statute AB 1437 codified at  
18 Cal. Health and Safety Code § 25996. On February 4, 2014 my colleagues at HSUS and I began  
19 seeking counsel to represent the HSUS in the Motion for Leave to Intervene to be filed in  
20 conjunction with this declaration, and preparing documents for filing.

21 4. Attached hereto as Exhibit A is a true and correct copy of a list prepared by  
22 California’s Department of Food and Agriculture (“CDFA”) showing all out-of-state (not  
23 California-based) egg producers and handlers currently registered to sell eggs into California.  
24 CDFA provided this list to me in response to my request for these public records submitted  
25 pursuant to California’s Public Records Act.

26 5. HSUS has campaigned in support of enacting state laws banning the sale of cruelly  
27 procured shark fins, *foie gras*, dogs from puppy mills, and horse meat, and HSUS has defended  
28 such laws in litigation.

1 I declare under penalty of perjury under the laws of the State of California and the United  
2 States of America that the foregoing is true and correct.
