The following issues need to be corrected prior to the FSIS walkthrough visit.

Slaughter Floor:

- The hand wash sink by the zero tolerance area leaking water when the water was being turned on.
- Rusty rails and support structures—ensure there is no flaking rust
- Peeling/curling paint on ceiling—flaking or peeling paint must be removed
- 3 x 3 foot hole in the ceiling above the evisceration station with old bucket left to catch rainwater

Chilling Cooler:

- Insufficient lighting for inspection
- · Remove flaking paint from walls

Cold Storage Cooler:

- Insufficient lighting for inspection
- Fan vents had rust—any flaking rust must be removed

Big Processing Room:

- Dripping water from overhead cooling system
- Any flaking rust removed from fan vents, fan covers, door frames

Small Processing Room:

Insufficient lighting

Outside of Premises:

- Ensure no harborage of rodents/pests
- No accumulation of junk/tires/pallets
- No composting of animal parts/waste

<u>Pen Area:</u> These issues do not have to be corrected prior to the walkthrough visit but if they result in injury to horses FSIS will document NRs

- · Loose channel iron and piping in pens
- Openings under troughs (horses could trip/catch foot)
- Abrupt ending concrete floors in pens (trip hazard)
- Rebar on part of pen floor—(could trip/catch shod horses)
- No numbering system or other system to identify which pens have received ante mortem inspection—309.1 requires all livestock receive ante mortem prior to slaughter. Horses that do not receive antemortem inspection prior to slaughter will not be eligible to bear

the mark of inspection. Therefore we strongly recommend implementing a system to identify which pens have received ante mortem inspection.
