

On 8/18/09 Jan Feldman (USDA APHIS AC Animal Care Inspector (ACI)) contacted DOLLARHITE relating to a Search for Unlicensed Activity. Jan Feldman documented she informed him of the licensing requirements, gave him a licensing kit and did a courtesy look at the rabbit pens (Exhibit 52).

On 8/20/09 Jan Feldman sent a email to her supervisor Dr. David Sabala (USDA APHIS AC Veterinary Medical Officer (VMO)) documenting her contact and conversation with DOLLARHITE on 8/18/09. Jan Feldman notes DOLLARHITE admitted to her he sold rabbits to (b)(4) and (b)(4) and DOLLARHITE seemed to understand that he was operating as a dealer without a license. Jan Feldman also noted DOLLARHITE was strongly opposed to licensing or government regulation of his business (Exhibit 53).

On 11/12/09 (b)(4) provided all their 2008-2009 purchase invoices from DOLLARHITE, confirmed by affidavit (b)(4) is licensed with USDA as a Exhibitor 43-C-003 (b)(4) also confirmed rabbit purchases from DOLLARHITE and noted they exhibited the purchased rabbits at their site in Branson Missouri and in addition to exhibiting the purchased DOLLARHITE rabbits the also sold the rabbits to their guest (Exhibit 63).

On 12/15/09 DOLLARHITE sold 8 rabbits & 6 guinea pigs to (b)(4) (Exhibit 65).
