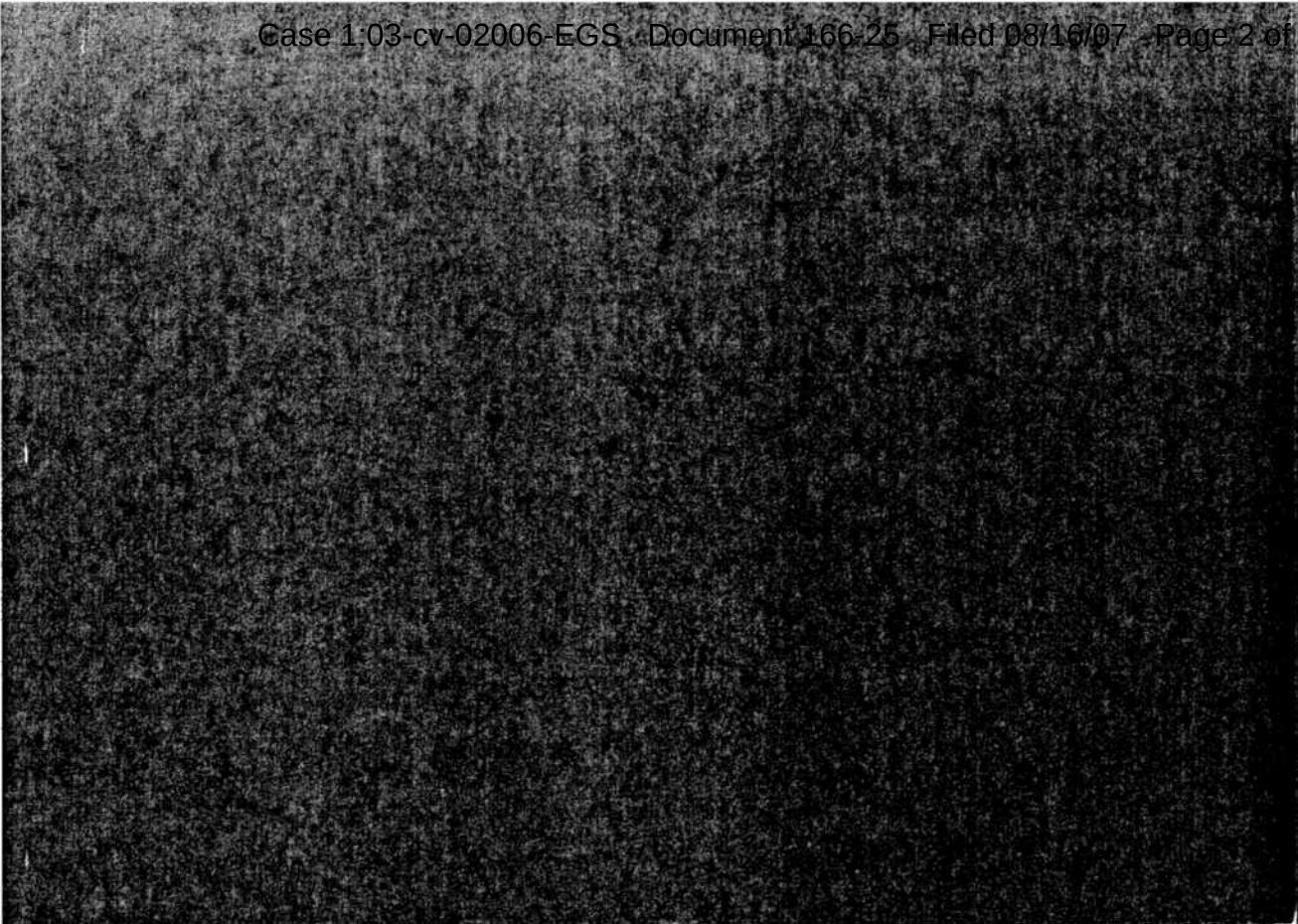

In an innovative case and the first of its kind in the country, the American Society for the Prevention of Cruelty to Animals (ASPCA), Animal Welfare Institute (AWI) and Fund for Animals (which has recently joined forces with the Humane Society of the United States) have sued Ringling Bros. and Barnum & Bailey under the Endangered Species Act for its mistreatment of Asian elephants.

The three non-profit organizations are joined by former Ringling Bros. employee Tom Rider, who left the circus to speak out about the elephant abuse he witnessed on a daily basis. Rider worked with the elephants for over two years and grew to love their extraordinary intelligence and gentle nature.

Numerous eye-witness accounts and other evidence of the mistreatment of the elephants, including the deaths of several baby elephants, has been collected for the lawsuit. Unfortunately, the non-profit organizations are up against Feld Entertainment—the parent company of Ringling Bros. and one of the richest corporations in the world. Therefore, we desperately need your help to raise money so we can successfully wage this battle on behalf of the elephants.
