Pursuant to Judge Facciola's Minute Order dated June 3, 2008, Feld Entertainment, Inc. ("FEI") is submitting for *in camera* review all of the documents subject to plaintiffs' February 15, 2008 Motion to Compel. Specifically, FEI is submitting all of the documents identified in the Revised Attachment to plaintiffs' Reply brief. See Plaintiffs' Reply (3/17/08) at 4 n.4 ("Plaintiffs have also amended the Attachment so that it now contains a complete list of each document that remains at issue").

Plaintiffs' Revised Attachment includes several documents that were not identified in the Original Attachment to their Motion. The Bates Numbers for these documents are: FEI 32301, 45997-99, 46001-04, 46005-09, 46011-12, 46014-17, 52157, 52158-59, 52161-63, 52170-71, and 52194-96. FEI objects to the belated identification of these documents and does not believe they were properly raised in the Motion. See FEI's Notice of Objection (3/28/08). If this omission is incorrect, please advise us.

For the Court's convenience, the enclosed documents are assembled (in redacted and original form) in the order identified in plaintiffs' Revised Attachment. FEI has highlighted in blue the portions of the original documents that were redacted. Please note, however, that one of

the documents identified in plaintiffs' Revised Attachment (FEI 42474-78) was inadvertently produced to plaintiffs out of page order. We are submitting the unredacted pages 42474, 42476 and 42478 for *in camera* review. Defense counsel had the originals reflected by pages 42475 and 42477, but is unable to locate them at this time. These documents were removed by counsel from production for the same reasons the other redactions were made because they did not relate to FEI's elephants, i.e. primarily other animals.
