

PE: BAR. Good BC. Feet look generally normal with no areas of inflammation. The cuticles are mildly overgrown, with possibly a few areas of chronically moist skin.
LB: Collected a sample of moist cuticle for DTM culture.
A: Moist dermatitis of unknown cause. Itching and location suggests fungal (athletes foot).
RX: Instructed handler to clean feet daily (conservative TX for now) If itching is observed again, consider antifungal medication (tinactin) (ri)
