SUBJECT: Patricia Zerbini

Jerry,

We are desirous of entering into a contractual agreement with Patricia Zerbini regarding the breeding of three Asian Elephants which are owned by Patricia Zerbini, whereas Ringling would receive the first three calves conceived.

Ringling will reserve the right to chose from the first three calves conceived as far as keeping them or giving up to two calves to Patricia Zerbini to satisfy the contractual concerns as they relate to Patricia Zerbini.

Patricia Zerbini is desirous of receiving two baby *Calves* elephants, either male or female and will consider this to be part of the contractual agreement.

Patricia Zerbini will retain ownership of the three Asian elephants.

The three Asian elephants for breeding consideration are:

Born 1/1/62

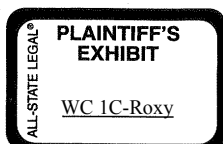
Bunny - Pre-convention copy of paperwork attached

We will attempt to breed these elephants at no cost to Patricia Zerbini.

We will retain the right to return these Elephants to Patricia Zerbini who will retain ownership, at anytime - providing she is given 90 days (three months) notification to ensure that she has time to make the necessary arrangements.

Patricia Zerbini will haul the three Asian elephants from Williston at her cost which will be coordinated with Doctor Houck to Polk City no later than Friday, January 24, 1997.

In addition Doctor Houck will identify Asian Elephants to be transferred back from Polk City to Williston by Patricia Zerbini again no later than Friday January 24, 1997.

Patricia Zerbini agrees to allow Ringling the use of the "Blue Barn" if necessary to accommodate the Asian elephants being transferred from Polk City (Ringling Elephants) to Williston at no additional charge for the duration of this breeding contractual agreement.

Upon the termination of this breeding contractual arrangement Patricia Zerbini will make the necessary arrangements at her cost to return the three Asian Elephants, Bunny, Roxy and Tilly to a location to be determined by Patricia Zerbini.

Additional Items to Address:

Patricia retains ownership of these animals - Ringling is not held liable to any health problems etc.

Ringling does not want any liability associated with these Animals.

Patricia will haul the animals back to an area of her designation at her cost. At this time the three elephants are being housed at the Williston facility. Patricia Zerbini is undertaking a contract with Circus Krone in Germany and may want to have the elephants sent over to Germany. *brm*

This agreement will terminate regardless of calving by these three elephants in six years or - after Ringling has received three calves - and two of the three Asian elephants have been diagnosed as being pregnant by a serum progesterone Ringling

In conversations with Doctor Houck he indicated that if none of the elephants have conceived within two years, chances are they won't and we would want to return them at that time.
