

I talked to Dr. Wm Lindsay, their veterinarian . about the elephants that are limping. Several animals have had arthritis for many years(at least 12). Lechamee ( 32 yrs). Sofle( 28yrs), Mini (42 yrs). The animals have warmed out so medication has not been given. If the condition was more pronounced, medication and retirement would happen if necessary.

Tb records on human personel: I was refused actual names of employees but see their results. I was referred to their corporate offices, since this is confidential medical information.

Standard ankas( or smaller ones) are used on the elephants, no electric prods are used.

The dogs have the old license numbers(new license # in April). Regional office should be contacted if they want to continue using the old tags.







-Tiger transport design has allowed excessively high temperatures during routine transport, per records maintained by tiger owner. ### Section 2.40 Veterinary Care

There is no documentation maintained on elephants that have minor lesions, scars or abrasions. Careful examination of the elephants revealed some scratches or lesions that may have required medical care, but there is no documentation of treatments. Procedures of treatments were described by the animal handlers but no documented records were maintained. Records of medical treatment were not available on the camel that recently had both rear feet caught in a train track. The procedures for treatment of this animal was described by the veterinarian and the animal handler. It is a requirement to document and have available records of treatment for animals requiring veterinary care. Programs must be established for documentation of treatments for any lesion/scar of any type that requires veterinary care. These programs must be established for all animals under your control. Correct by September 14, 2000.

### Section 3.125(c) Storage

Perishable items were seen in a trailer near toxic substances. Breads and Carrots were in plastic bags and were stored in a trailer with a can of spray paint, gas operated pressure washer and several discarded drink containers. Bananas were in two boxes beneath a trailer on the asphalt

(b)(1) During public exhibition, any animal must be handled so there is minimal risk of harm to the animal and to the public, with sufficient distance and/or barriers between the animal and the general viewing public so as to assure the safety of animals and the public.

Between approximately 0830 and 0900 hours on July 11, 2006 the Ringling Bros. train carrying eight Asian elephants was parked on the railroad tracks near the intersection of Ventura Street and Santa Fe Avenue in Fresno, California with insufficient barriers between the animals and the public. Shortly after arriving at this location at 0830 hours three APHIS personnel who were waiting for the train were able to approach and walk unchallenged directly to the open doors of the elephant cars. Additionally, we observed an individual who later identified himself as a local newspaper photographer lean into the open doors of several cars containing elephants in order to take photographs. The only Ringling Bros. personnel observed during this time was one individual who was cleaning in one of the elephant cars. This person did instruct us to move away from the door when we approached that car. He also leaned out and asked us to step away several minutes later. By that time the person who identified himself as a photographer was observed to lean inside most of the elephant cars with his camera. Additionally, at least one local television station had broadcast a story the previous evening stating that the animal walk from the train would begin at 0900 hours, so by the time the additional personnel arrived numerous cars had parked on the road (Santa Fe Ave.) next to the tracks and people were lining up to watch. There was a chain link fence between Santa Fe Ave. and the tracks; however the train was easily accessed by walking around the fence, as had the APHIS personnel and photographer.

The lack of an adequate perimeter fence, or other appropriate alternative security measure in this instance, failed to ensure that there was sufficient distance and/or barriers between the animals and the general viewing public so as to assure the safety of both the animals and the public. Under these circumstances a member of the public would have been able to enter the cars and approach the animals, thus jeopardizing their own safety, or place items inside the cars that could adversely affect the well-being of the animals. A system should be in place to ensure that appropriate security is provided when the train containing animals is stopped on the railroad tracks.






