Saint Louis County Police Department Investigative Report 14-43984

The following information relates to the Saint Louis County Police Department's investigation of a homicide that occurred on Saturday, August 9, 2014 at approximately 12:02 p.m., near 2947 Canfield Drive, in the City of Ferguson, within Saint Louis County, Missouri.

On Saturday, August 9, 2014, at approximately 12:43 p.m., Detective Sergeant of the Saint Louis County Police Department's Division of Criminal Investigation, Bureau of Crimes Against Persons, received a phone call from the Saint Louis County Police Department's Bureau of Communications. Detective Sergeant was notified of a homicide where an on-duty police officer from the City of Ferguson had discharged his firearm and shot a male. The male had been pronounced deceased at the scene by responding paramedics from Christian Hospital EMS. The Ferguson Police Department was requesting the Saint Louis County Police Department conduct an investigation into the incident.

Accordingly, the following detectives from the Saint Louis County Police Department's Division of Criminal Investigation, Bureau of Crimes Against Persons, drove to the scene:

Detectives began arriving at the scene at 2947 Canfield Drive at approximately 1:30 p.m. There was a large crowd of bystanders and a large uniformed police presence at the scene when detectives arrived.

As Detective and Detective were walking toward the scene, they were approached by a female who identified herself as:

McSpadden stated her son had been shot by a Ferguson police officer and was lying in the street. McSpadden provided identifying information on her son to include:

A Mohawk style haircut Medium complexion 6'4", 280lbs "Big Mike" tattoo on his left forearm

The identifiers provided by McSpadden were later used for a preliminary identification of Brown.

McSpadden was provided contact information for detectives and agreed to remain in contact during the course of the investigation.

The scene near 2947 Canfield Drive had been cordoned off with yellow crime scene tape, and police officers from both the Ferguson Police Department and the Saint Louis County Police Department were standing at various points around the tape preserving the scene. There were groups of bystanders just outside the yellow crime scene tape at points all around the scene. Many individuals were clearly upset and were expressing their frustration, by at times yelling obscenities and threats, and attempting to encroach on the crime scene itself.

The following detectives from the Saint Louis County Police Department's Division of Criminal Investigation, Bureau of Criminal Identification, Crime Scene Unit, arrived at the scene:

Detectives from the Bureau of Crimes Against Persons briefly spoke with Chief who directed detectives to speak with Sergeant the on-duty Ferguson supervisor when the incident took place. Chief indicated Sergeant had the most detailed knowledge of the incident.

Detectives briefly spoke with Sergeant in order to learn the general circumstances of the incident. Sergeant confirmed he was the on-duty supervisor for the Ferguson Police Department and the first supervisor at the scene after the homicide took place. Sergeant said he drove to the scene after hearing over his department radio that he was being requested at the Canfield Green Apartment Complex.

After arriving at the complex, Sergeant briefly spoke with Police Officer Darren Wilson, DSN 609, of the Ferguson Police Department. Sergeant provided the following information about his conversation with P.O. Darren Wilson. P.O. Darren Wilson indicated to him that he had been involved in a shooting and the subject of the shooting was now deceased. Sergeant indicated P.O. Darren Wilson had previously told the subject, who had been walking down the middle of Canfield Drive with another male, to get out of the roadway and over to the sidewalk. Sergeant indicated P.O. Darren Wilson attempted to exit his vehicle and contact the males. As he attempted to exit his vehicle, a struggle involving the driver's side door began after the subject shut the driver's side door on him. The subject would not let P.O. Darren Wilson get out of his vehicle. The subject began assaulting P.O. Darren Wilson through the driver's side window while P.O. Darren Wilson was still inside his police vehicle. The assault escalated to the point where the subject tried to take P.O. Darren Wilson's firearm and P.O. Darren Wilson fired at least one gunshot while inside the vehicle.

The subject ran away from the vehicle and ran east on Canfield Drive. P.O. Darren Wilson exited his vehicle and gave chase on foot. During the foot chase, the subject turned around and began running toward P.O. Darren Wilson. P.O. Darren Wilson indicated to Sergeant that, as the subject was charging toward him, P.O. Darren Wilson fired his weapon to stop the subject from assaulting him further.

Sergeant did not believe the subject displayed a gun and the whereabouts of the second male were unknown.

Sergeant indicated P.O. and P.O. both of the Ferguson Police Department, were the first two officers to arrive at the scene after the incident took place.

Sergeant directed P.O. Darren Wilson to leave the scene, return to the Ferguson Police Department and await instructions. Sergeant based this decision on upset individuals at the scene who were directing their anger toward P.O. Darren Wilson.

Sergeant agreed to complete a detailed recorded interview at a later time.

At the conclusion of the conversation with Sergeant detectives from the Bureau of Crimes Against Persons initiated the investigation within the crime scene. Detective was directed to document the scene. Detective was directed to interview P.O. Detective was directed to interview P.O. Darren Wilson at the Ferguson Police Department. Detective was directed to interview a female who had presented herself as a witness to uniformed officers at the scene.

Detective directed his attention to the scene, noting the incident took place in the 2900 block of Canfield Drive. The 2900 block of Canfield Drive sits within the Canfield Green Apartment Complex, a 414 unit, 18 building complex. The complex is owned by Numerous apartment buildings made of framed and brick construction sit on both the north and south sides of Canfield Drive.

The 2900 block of Canfield Drive is a two-way street of asphalt construction and sits entirely within the Canfield Green Apartment Complex. Within the complex, Canfield Drive runs slightly southeast and northwest. A double yellow line separates the two lanes of traffic. At the eastern end of the complex, the roadway changes names to Windward Court. Adjacent to the Canfield Green Apartment Complex, on the eastern end, is the Northwinds Apartment Complex. At the western end of the complex, the 3000 block of Canfield Drive changes to an area consisting of single family homes. Further west of the single family homes, is the intersection of West Florissant Avenue and Canfield Drive.

The incident, as well as the investigation, took place during daylight hours.

The scene encompassed the roadway between approximately 2964 Canfield Drive and the intersection of Canfield Drive at Coppercreek Court.

Prior to the arrival of detectives from the Saint Louis County Police Department, several orange traffic cones had been placed at various locations near items of apparent evidentiary value.

Detective first directed his attention to the middle of Canfield Drive in front of the address identified as 2964 Canfield Drive. A fully marked Ferguson Police Department patrol vehicle identified as:

was parked at an angle, primarily in the northwest traffic lane on Canfield Drive, facing north. The rear left tire was nearly sitting on the double yellow line.

Detective observed all four of the doors to the vehicle were closed and all the windows in the vehicle were up with the exception of the driver's window. The driver's window appeared to have been shattered based on small pieces of glass on the ground and inside of the vehicle. The vehicle's windows were tinted with the exception of the front windshield and the front passenger window. The shattered front driver's window appeared not to have been tinted based on the shattered pieces of glass on the ground and in the vehicle. The exterior driver's side mirror was bent forward toward the front of the vehicle. In approximately the exterior upper center half of the driver's side front door was apparent human tissue. Slightly below the front exterior driver's side door handle, was a defect in the door, with a small bugle protruding outward. At the point of this bulge, a small amount of paint was missing. Detective also observed a small amount of apparent blood on the exterior rear driver's side door in approximately the middle of the door. This apparent blood was just above the vehicle's decal striping.

On the rear window were apparent finger and hand smudge marks in dust. This was later determined to have been of no evidentiary value as the dirt and marks on the vehicle had been mentioned during the Ferguson Police Department's morning roll call. Sergeant observed the markings on the back of the car and told P.O. Darren Wilson to get the vehicle washed during his shift.

The vehicle had been wrapped in yellow crime scene tape prior to detectives from the Saint Louis County Police Department's Bureau of Crimes Against Persons arriving at the scene.

Detective directed his attention to the asphalt road around Ferguson patrol vehicle and observed the following items on the roadway:

- A yellow/black/white bracelet was near the front driver's side tire
- A red Saint Louis Cardinals baseball hat was upside down south of the front driver's side tire
- Broken glass was just south of the front driver's side door
- A single spent cartridge casing head stamped "FEDERAL 40 S&W" was just south of the rear driver's side door
- A single spent cartridge casing head stamped "FEDERAL 40 S&W" was along the southern curb, south of Ferguson Patrol vehicle
- A brown bracelet was under the vehicle behind the front passenger side tire

Traveling approximately southeast on Canfield Drive from Ferguson patrol vehicle in the southeast lane of traffic, was a "Nike" brand white and black sandal. This sandal was positioned upside down with the toe of the sandal facing approximately northwest. Further southeast from this sandal, also in the southeast lane of traffic, near the double yellow line, was the other matching sandal. This item was approximately in front of 2960 Canfield Drive. This second sandal was positioned right side up with the toe facing south.

Near the intersection of Canfield Drive at Caddiefield Road, parked across the middle of Canfield Drive facing north, was the following fully marked Ferguson Police Department patrol vehicle:

On Caddiefield Road at Canfield Drive, parked facing in a southeast direction, was the following fully marked Saint Louis County Police Department patrol vehicle:

In the middle of Canfield Drive at Coppercreek Court, parked across the middle of Canfield Drive facing north, was the following fully marked Ferguson Police Department patrol vehicle:

2013 Chevrolet Tahoe

White in color with Ferguson Police Department decals on both the sides of the vehicle License Plate: City of Ferguson Vehicle Identification Number

Vehicles had been positioned at their respective locations after the incident took place in order to aid in preserving the scene.

Detective directed his attention to the area on Canfield Drive between the two marked Ferguson Police vehicles identified as . Within this area of concentration was the victim who had been covered with a white sheet prior to detectives from the Saint Louis County Police Department's Bureau of Crimes Against Persons' arrival. The victim was approximately in the center of the roadway in front of 2943 Canfield Drive.

During the course of the investigation, detectives from the Saint Louis County Police Department's Crime Scene Unit, placed orange screens around the victim.

In the area around the victim, the following items of evidentiary value were located:

Northwest of Ferguson patrol vehicle , in the northwest lane of traffic on Canfield Drive, were apparent blood droplets in the roadway. The apparent blood droplets formed a small trail on the roadway. The droplets extended between an area slightly west of Coppercreek Court and where the victim's body was located in approximately the center of the roadway.

Continuing approximately west from the apparent blood droplets, and closer to the victim, were two spent cartridge casings head stamped "FEDERAL 40 S&W" in approximately the middle of the roadway on Canfield Drive.

Approximately south of these spent cartridge casings, in the southeast lane of traffic on Canfield Drive and closer to the curb, were two spent cartridge casings head stamped "FEDERAL 40 S&W."

Just west of these spent cartridge casings, also in the southeast lane of traffic on Canfield Drive was a spent cartridge casing head stamped "FEDERAL 40 S&W."

South of this spent cartridge casing, in the grass area between the southeast lane of traffic on Canfield Drive and the sidewalk, were four spent cartridge casings head stamped "FEDERAL 40 S&W."

Northeast of the victim, in the northwest lane of traffic on Canfield Drive, was an apparent projectile.

South of the victim, in the southeast lane of traffic on Canfield Drive, just east of Caddiefield Road, was a spent cartridge casing head stamped "FEDERAL 40 S&W."

Full details of the locations of the items, to include specific measurements, can be seen on the associated diagram completed by the Saint Louis County Police Department's Crime Scene Unit.

As the scene investigation continued, there were several large groups of hostile individuals around the perimeter of the crime scene. The investigation of the scene was interrupted several times by death threats directed toward police officers and gunshots being fired by an unknown persons around the crime scene.

Medicolegal Death Investigator of the Saint Louis County Medical Examiner's Office arrived at the scene at approximately 2:30 p.m. and conducted his investigation once it was safe to do so. For more information regarding this investigation, reference should be made to Saint Louis County Medical Examiner's Office Report Number 14-5143.

During Investigator time at the scene, he removed the white sheet covering the victim. After the removal of the sheet, detectives took note of identifying information on the victim, which was consistent with the description Lesley McSpadden provided for her son, Michael Brown.

Detective observed Brown was lying on his stomach with his head facing approximately west and his feet facing approximately east on Canfield Drive. Brown was wearing a light gray T-shirt, blue underwear, khaki shorts, a black belt, and tall yellow socks with apparent black marijuana leaves on them.

The right side of Brown's face was resting on the roadway. Apparent blood was on the roadway near Brown's head and had traveled in a western direction away from Brown. Brown's left arm was partially bent at the elbow with his left hand near the waist of his pants with his palm up. There was nothing in his left hand. Brown's right arm was straight and slightly away from the lower portion of his body, in an approximately northeast direction. His right palm was face up. There was nothing in his right hand.

During Investigator examination, Brown's body was moved from his stomach to his back. Detective observed Brown had visible injures, consistent with gunshot wounds, to the following areas of his body:

Right hand Right arm Head Left forearm The specifics of those and other injuries, which were not readily visible at the scene, are fully documented in the post-mortem examination report.

Investigator inventoried Brown's pockets at the scene. In his right front pocket were two five dollar United States Currency bills and a notepad. In his left front pocket was a red lighter and a black lighter.

Investigator then secured brown paper bags over both of Brown's hands.

During the examination of Brown, two individuals who only identified themselves as relatives of Brown, were permitted inside the crime scene tape and escorted by Captain of the Saint Louis County Police Department's Division of Patrol, North County Precinct. Detective Sergeant requested the two individuals stand outside of the tape and they complied.

At the conclusion of investigation, representatives from Saint Louis Livery placed Brown into a secure transportation bag and transported Brown's body to the Saint Louis County Medical Examiner's Office, located at 6509 Helen Avenue Saint Louis, Missouri 63134.

During the investigation at the scene, Detective also noted and directed his attention to the apartment building known and numbered as 2960 Canfield Drive. Detective observed this building's exterior consisted of brick and vinyl siding. On the north side of this building, was damage consistent with having been struck by a projectile. The damage was to the vinyl siding above the easternmost window on the first level. Detectives from the Saint Louis County Police Department's Crime Scene Unit attempted to extract a possible projectile from the building but were unable to do so due to the construction of the building and the significant structural damage that would have been required to remove an item. The interior of the building was checked and there was no penetration to the interior of the apartment.

Detective also noted that, northwest of Ferguson Patrol vehicle , off of Canfield Drive, was a semi-circular roadway/parking lot, identified as Canfield Drive. In the parking lot, in front of the apartment buildings identified as 2973 Canfield Drive and 2969 Canfield Drive was a vehicle. This vehicle was reported to both Detective and Detective as having been occupied by a witness during the incident. This vehicle was parked facing Canfield Drive at the time of the investigation. The vehicle was fully identified as:

Details regarding this vehicle and its occupant are documented later in this investigative report.

No security video cameras were present within the apartment complex. While at the scene, Detective spoke with P.O. the Public Relations Representative for the Ferguson Police Department, who indicated there were no security video cameras maintained by the complex and there was not a private company providing security video surveillance on behalf of the complex.

At approximately 1:45 p.m., Detective made contact with P.O. who was still at the scene.

P.O. was dressed in full department uniform and was operating marked police vehicle for his shift on August 9, 2014. P.O. was scheduled to work the day shift from 6:30 a.m. to 6:30 p.m. and was utilizing radio call sign

Detective to recall the events of the day and he agreed to do so. P.O. asked P.O. stated the shift had been "crazy," which caused many of the police units to be handling calls and activity outside of their regularly assigned areas. P.O. received a call for service regarding a theft from the Ferguson Market, located at 9101 West Florissant Avenue in Ferguson, Missouri. The description of the theft suspect was a black male wearing a white T-shirt and who was then walking northbound on West Florissant Avenue from that location. P.O. conducted a canvass of the area, but was unable to locate the drove to the scene at the Ferguson Market and made contact with the clerk, who subject. P.O. provided a more thorough description of the suspect. The clerk stated the suspect was a black male, wearing a red Cardinals baseball hat, a white T-shirt, khaki colored cargo shorts, and yellow socks. P.O. departed the Ferguson Market and responded to the Quiktrip, located at 9420 West Florissant Avenue in Ferguson, Missouri, continuing his canvass of the area. His inspection of Quiktrip did not locate the suspect and he returned to his marked patrol vehicle.

- P.O. heard P.O. Darren Wilson call out over the department radio. P.O. Darren Wilson requested an assist unit and provided his location. P.O. described P.O. Darren Wilson's voice to be "excited." Knowing P.O. Darren Wilson's location was in very close proximity to his own, P.O. activated his emergency lights and sirens and headed in P.O. Darren Wilson's direction. As he rounded the curve in the 3000 block of Canfield Drive, he heard four gunshots in succession. As he drove through the curve, he had an unobstructed view of the street. P.O. observed a male lying on the pavement and P.O. Darren Wilson was standing near him, approximately three or four feet away, in the low ready position. P.O. parked and exited his vehicle. He approached and observed the male to be motionless and bleeding heavily.
- P.O. immediately requested the dispatcher have EMS, a supervisor, and Ferguson detectives respond to the scene. He directed P.O. , who arrived shortly after him, to begin taping off the crime scene and secure it. P.O. was immediately concerned with preserving the scene and preventing further incidents from occurring.
- P.O. observed P.O. Darren Wilson's uniform to be disheveled and the shirt pocket to be open. He further observed discoloration and swelling to the side of P.O. Darren Wilson's face and blood on his hand. Believing he was just involved in a "scuffle," P.O. asked him, "Are you ok?" P.O. Darren Wilson replied, "I'm fine."
- P.O. observed his supervisor, Sergeant arrive at the scene moments later. It was determined that P.O. Darren Wilson would drive himself to the Ferguson Police Station to remove himself from the scene.

He was seated in an uninvolved, marked Ferguson police car before departing the scene for the Ferguson Police Department.

P.O. began to mark potential evidence with cones and maintain the scene.

An EMS unit which had been in the area and was leaving a call for service was flagged down. The EMS Unit was later determined to be Christian Hospital EMS and had recently departed a sick case at Glenark Drive. The EMS Unit was manned by Paramedic Paramedic touched the body and was unable to discover a pulse. He contacted the hospital.

Shortly after, the EMS unit that was requested through the dispatcher arrived. Christian Hospital EMS manned by Paramedic and Paramedic surveyed the body and determined it was unnecessary to touch or alter the body.

P.O. believed the body was covered first by a blanket by a Fire/EMS Unit and an additional blanket was later placed on him possibly by Sergeant and Lieutenant of the Ferguson Police Department.

Detective asked P.O. if he observed anyone else in the vicinity of the immediate crime scene. He stated that he was unsure, as he developed "tunnel vision" after seeing P.O. Darren Wilson and the body lying in the street. He stated within approximately 30 seconds, many people began to come outside and surround the scene.

Detective asked P.O. if it was unusual for P.O. Darren Wilson to appear disheveled in his uniform. P.O. stated it was very unusual as he is usually very clean and pressed, with his uniform shirt being straight and proper.

Detective asked P.O. if he saw any of the altercation at all. He stated he did not, and only heard the shots.

P.O. could add nothing further and the interview was concluded.

Detective directed Detective to conduct an interview with Ferguson Police Officer who had responded to assist P.O. Darren Wilson.

At approximately 1:45 p.m., Detective made contact with P.O. who was still at the scene.

- P.O. was dressed in full department uniform and was operating marked police vehicle for his shift on August 9, 2014. P.O. was scheduled to work the day shift from 6:30 a.m. to 6:30 p.m. and was utilizing radio call sign
- P.O. said prior to this incident, he had been directed by dispatch to an illegally parked vehicle. P.O. was traveling north on West Florissant Avenue approaching Highmont Drive when he heard a radio transmission from P.O. Darren Wilson to the dispatcher. P.O. recalled P.O. Darren Wilson's transmission was something to the effect of, "Frank 21, I'm on Canfield with two, send me another car." P.O. said

- P.O. Darren Wilson's voice was composed but sounded concerned. P.O. said he worked closely with P.O. Darren Wilson and he could tell by the sound of his voice that something was wrong.
- P.O. activated his emergency lights and turned his patrol vehicle around in order to travel south on West Florissant Avenue toward Canfield Drive. After reaching Canfield Drive, P.O. turned left, traveling east on Canfield Drive. P.O. said he arrived in the area at the same time as P.O. . P.O. said after arriving at the scene, he observed P.O. Darren Wilson's marked Ferguson patrol vehicle stopped in the roadway facing west. P.O. stopped his vehicle along the south curb of the roadway, and exited his vehicle. P.O. said as he exited his vehicle, he observed P.O. Darren Wilson standing in the roadway approximately 30 feet east of him. P.O. Darren Wilson had his duty weapon in his hand and was pointing it toward the ground. On the ground in front of P.O. Darren Wilson was an individual who was later identified as Michael Brown.
- P.O. said he immediately ran east toward P.O. Darren Wilson in order to assist. After reaching P.O. Darren Wilson's location, P.O. realized the person on the ground had been shot. P.O. said he did not ask P.O. Darren Wilson what happened but he assumed P.O. Darren Wilson had shot the person. P.O. clarified by saying he could see that P.O. Darren Wilson was visibly shaken and upset. P.O. asked P.O. Darren Wilson if he was okay to which he replied he was. P.O. Darren Wilson requested P.O. secure the scene with crime scene tape. P.O. immediately ran to his vehicle and retrieved his crime scene tape which he used to cordon off the area. After securing the area, P.O. again went to P.O. Darren Wilson and asked if he was okay. P.O. Darren Wilson said he was okay. P.O. said he then left P.O. Darren Wilson's side and attempted to make sure no unauthorized personnel entered the scene.

Detective asked P.O. if he heard gunshots or any additional radio transmissions while driving to the scene. P.O. said he did not hear any gunshots and was unaware that anyone had been shot until he arrived on scene. P.O. said he was on scene quickly after hearing P.O. Darren Wilson's request for assistance so he did not believe P.O. Darren Wilson had an opportunity to radio for help a second time.

- P.O. advised Detective that after he and P.O. arrived on scene, P.O. responded to the side of P.O. Darren Wilson and remained with him while on scene.
- P.O. was unable to provide any additional information and the interview was concluded.

Detective was directed to respond to the Ferguson Police Department located at 222 South Florissant Road in Ferguson, Missouri to contact P.O. Darren Wilson.

After arriving at approximately 2:00 p.m., Detective met with Lieutenant Colonel of the Ferguson Police Department. Lieutenant Colonel escorted Detective to the office of the Ferguson Detective Bureau where he met with P.O. Darren Wilson. Also present in the room was Detective R. of the Ferguson Police Department and P.O. Darren Wilson's attorney,

Initially, Detective observed P.O. Darren Wilson to be dressed in full Ferguson Police Department uniform with the exception of a duty belt. Detective observed several apparent injuries to P.O. Darren Wilson. Specifically, the left and right side of P.O. Darren Wilson's face were red and swollen. P.O. Darren

Wilson's left ear was also red and swollen. Scratches were present to the left side of P.O. Darren Wilson's neck. A large abrasion was present at the base of P.O. Darren Wilson's neck.

As Detective took note of the injuries, P.O. Darren Wilson directed Detective attention to a duty belt sitting on the floor, near the area of Detective desk. Detective observed the duty belt to be void of a firearm. P.O. Darren Wilson then directed Detective attention to a yellow evidence envelope sitting atop Detective desk. P.O. Darren Wilson indicated his weapon was packaged as evidence and secured within the envelope.

It was then determined by Lieutenant Colonel that P.O. Darren Wilson would be conveyed to Christian Northwest Emergency Room for a medical evaluation. P.O. Darren Wilson removed his uniform shirt and draped it over a chair by Detective desk. Prior to departing the police department, Detective indicated he would maintain custody of P.O. Darren Wilson's duty belt, shirt, and firearm.

P.O. Darren Wilson was conveyed by Lieutenant Colonel to Christian Northwest Hospital Emergency Room, located at 1225 Graham Road, Florissant, Missouri 63031, for a medical evaluation and treatment. Also present in the vehicle was

Detective drove to Christian Northwest Hospital. While driving, Detective contacted Detective Division of Criminal Investigation, Bureau of Criminal Identification, Crime Scene Unit, and requested he meet them at the hospital to photograph P.O. Darren Wilson.

After arriving at the hospital at approximately 2:15 p.m., Detective entered a trauma room and contacted P.O. Darren Wilson. Also present in the room was Detective Lieutenant Colonel and Detective photographed the visible injuries present on P.O. Darren Wilson's head, neck, and shoulders.

After completing the photographs, Detective and Lieutenant Colonel departed the trauma room. Detective asked P.O. Darren Wilson if he would provide his account of the incident. P.O. Darren Wilson agreed to do so.

P.O. Darren Wilson explained he was currently employed by the Ferguson Police Department and had been a police officer for five years. P.O. Darren Wilson indicated he was on-duty at the time of the incident and was assigned to Sector 1 and utilized radio call sign F-21. P.O. Darren Wilson's shift began at 6:30 a.m. and he was scheduled to end his shift at 6:30 p.m. During his tour of duty, P.O. Darren Wilson was operating fully marked Ferguson Police Department vehicle

Prior to the incident taking place, P.O. Darren Wilson had just completed an unrelated radio assignment of a sick case. After completing the radio assignment, he drove west on Canfield Drive. While driving, P.O. Darren Wilson heard on his department radio, a broadcast of a stealing reported to have occurred at 9101 West Florissant Avenue. During the broadcast, a suspect description was provided. The suspect was described as a black male, wearing a black T-shirt and brown shorts. The broadcast also identified that cigarillos were taken during the stealing.

P.O. Darren Wilson stated he observed two unknown subjects walking toward his location from the area of Canfield Drive and West Florissant Avenue. P.O. Darren Wilson described the individuals as:

Black Male, dark complexion, approximately 5'5", thin build, short dreadlock style hair, wearing a black T-shirt. This individual was later identified as Dorian Johnson. Although, P.O. Darren Wilson did not know Johnson at the time, for clarity purposes, he will be identified as Johnson for the remainder of P.O. Darren Wilson's statement.

Black Male, medium complexion, approximately 6'3", approximately 270 pounds, clean shaven, wearing red baseball style hat, gray shirt, khaki shorts, yellow socks. This individual was later identified as Michael Brown. Although, P.O. Darren Wilson did not know Brown at the time, for clarity purposes, he will be identified as Brown for the remainder of P.O. Darren Wilson's statement.

- P.O. Darren Wilson stopped his patrol vehicle and allowed the subjects to approach. With his window down, P.O. Darren Wilson stated, "Hey guys, why don't you walk on the sidewalk?" P.O. Darren Wilson indicated Johnson stated, "We are almost to our destination." This statement was quickly followed by Brown stating, "The fuck with what you say." Both subjects continued to walk past the patrol vehicle.
- P.O. Darren Wilson notified his dispatcher he would be conducting a pedestrian check on Canfield Drive and requested an assist officer. P.O. Darren Wilson then placed his patrol vehicle in reverse and backed up toward the subjects and stated, "Hey, come here."
- As P.O. Darren Wilson opened the driver's door of his patrol vehicle, the door was slammed shut by Brown. P.O. Darren Wilson ordered Brown to get back and then attempted to open the driver's door again. The door was then slammed shut again by Brown, who then placed both of his hands on the door, near the lower portion of the window frame, and held it shut. P.O. Darren Wilson stated he gave Brown several commands to get back and move away from the vehicle.
- As P.O. Darren Wilson was giving Brown commands, Brown thrust his upper body into the open window of the patrol vehicle. Brown immediately started punching P.O. Darren Wilson multiple times in the face and shoulders by "swinging wildly." P.O. Darren Wilson indicated during the initial assault, he was struck on the left side of his chin, chest and shoulders. P.O. Darren Wilson began attempting to deflect the strikes with both hands and his left arm while ordering Brown to stop.
- P.O. Darren Wilson observed Brown reach back with his left hand and give something to Johnson, stating "Here, take this." Brown then used his left hand to strike P.O. Darren Wilson with a closed fist on the right side of his face. This "stunned" P.O. Darren Wilson. P.O. Darren Wilson attempted to retrieve his department issued mace from his duty belt; however, due to him being in the seated position he was unable to. Additionally, P.O. Darren Wilson believed his collapsible baton would be ineffective due to the confined space.
- P.O. Darren Wilson indicated he felt Brown was overpowering him due to his size and position. P.O. Darren Wilson explained he could not escape or retreat through the passenger side of the vehicle as the radio and computer were situated in such a manner that prevented it. P.O. Darren Wilson created distance with Brown by pushing away with his left hand and then retrieved his department issued firearm with his right hand. P.O. Darren Wilson yelled, "Stop or I will shoot." As P.O. Darren Wilson was raising the firearm, Brown grabbed the

top of the gun. P.O. Darren Wilson explained that Brown's hand was large enough to encompass the top of the slide, a large portion of the handgrips, and the trigger guard. Brown then yelled, "You're too much of a pussy to shoot me."

- P.O. Darren Wilson ordered Brown to "stop" and "get back". Brown did not comply. Brown then forced the barrel of the weapon in a downward angle, at which time P.O. Darren Wilson felt the barrel press into his left hip. P.O. Darren Wilson could feel the fingers of Brown's hands moving near the trigger and trigger guard of the firearm. Fearing that Brown was attempting to shoot him, P.O. Darren Wilson placed his left hand against the frame of the firearm and began to push the gun away from himself while moving his hips to the right, away from the gun. P.O. Darren Wilson attempted to stop the threat by discharging a round of ammunition. P.O. Darren Wilson was able to pull the trigger of the firearm; however, the weapon malfunctioned. P.O. Darren Wilson believed the misfire was due to Brown's hand preventing the weapon from functioning normally.
- P.O. Darren Wilson then pulled the trigger an additional time; however, the weapon again malfunctioned. P.O. Darren Wilson pulled the trigger again for the third time. The firearm discharged one round of ammunition which traveled through the driver's door. Immediately following the shot, P.O. Darren Wilson observed a large explosion of glass shards as the window shattered. P.O. Darren Wilson observed his hands were covered with apparent blood but was unsure who was injured.
- P.O. Darren Wilson stated Brown re-entered the vehicle through the driver's window. Brown struck P.O. Darren Wilson in the face several times with a closed fist. Brown ceased the assault and then fled east on Canfield Drive.
- P.O. Darren Wilson exited his patrol vehicle and notified his dispatcher that shots were fired and requested additional assist officers. P.O. Darren Wilson then chased Brown on foot and gave him several loud verbal commands to stop and get on the ground. Brown ignored the commands and continued to flee.
- As P.O. Darren Wilson was running, Brown stopped and turned around. According to P.O. Darren Wilson, Brown had an "intense" and "psychotic" look on his face. Brown immediately placed his right hand into the waistband of his pants. P.O. Darren Wilson stopped, leaving a gap of approximately 30 feet. P.O. Darren Wilson gave Brown a command to get on the ground. Due to the recent assault on P.O. Darren Wilson and Brown's action of placing his hand near his waistband, P.O. Darren Wilson still had his firearm in his hand and had it pointed at Brown. Brown then screamed something inaudible and began to "charge" P.O. Darren Wilson. P.O. Darren Wilson stated he began to back pedal with attempts to create or keep the distance between himself and Brown. P.O. Darren Wilson explained that he knew if Brown reached him, he would "be done" as Brown had already overpowered him once during the assault inside of the patrol vehicle.
- P.O. Darren Wilson continued to give Brown commands to stop; however, Brown ignored them. Once Brown got within approximately 15 feet of him, P.O. Darren Wilson indicated he discharged five rounds to stop the threat. According to P.O. Darren Wilson, this did not slow Brown down and he continued to advance. P.O. Darren Wilson discharged two additional rounds; however, Brown continued to advance.

- P.O. Darren Wilson stated Brown then leaned forward and appeared as if he (Brown) was attempting to "tackle" him. P.O. Darren Wilson then discharged one additional round to stop the threat. Brown then fell to the ground, ending the threat.
- P.O. Darren Wilson then notified the dispatcher and requested additional assistance and a supervisor by stating, "Send me every car you got and a supervisor." P.O. Darren Wilson indicated P.O. was the first car to respond, and he requested paramedics be dispatched to the scene.

After the arrival of Sergeant he instructed P.O. Darren Wilson to return to the Ferguson Police Department. While at the station, P.O. Darren Wilson observed apparent blood on the back of his left forearm and the front of his right hand. P.O. Darren Wilson washed the blood from his hands.

- P.O. Darren Wilson then conducted a safety inspection of his firearm. Upon doing so, he ejected the magazine, which was empty. P.O. Darren Wilson then found one live cartridge of ammunition in the chamber of his firearm. P.O. Darren Wilson packaged the firearm in an evidence envelope and remanded custody of the firearm to Detective
- P.O. Darren Wilson and agreed to make themselves available at a later time to provide a formal recorded statement.

This concluded the interview with P.O. Darren Wilson.

P.O. Darren Wilson was treated by Registered Nurse and Physician's Assistant
P.O. Darren Wilson was released from the hospital and rode with Lieutenant Colonel and his attorney back to the Ferguson Police Department. P.O. Darren Wilson arrived at approximately 4:30 p.m.

Once at the Ferguson Police Department, Detective arrived and seized the uniform worn by P.O. Darren Wilson.

Detective and Detective conducted an inspection of P.O. Darren Wilson's department issued firearm, as well as his reserve magazines on his duty belt, which he had in his possession at the time of the incident. This inspection was conducted in the presence of Detective who had taken custody of the firearm during P.O. Darren Wilson's medical treatment. The inspection revealed both reserve magazines to be loaded with twelve live cartridges of .40 caliber ammunition head stamped "FEDERAL 40 S&W."

Detective and Detective then inspected the contents of the Ferguson Police Department evidence envelope containing P.O. Darren Wilson's firearm. The contents included one empty magazine for a Sig Sauer P229, a single live cartridge of ammunition head stamped "FEDERAL 40 S&W," and P.O. Darren Wilson's firearm. The firearm was fully described as:

Black, Sig Sauer P229 semi-automatic pistol, Ferguson Police Department emblem inscribed on the top of the slide, serial number 55B003794

Detective observed a reddish substance, consistent with blood, to be present on the slide and frame of the firearm.

The magazine, live cartridge of ammunition, and firearm were seized as evidence by Detective Reference should be made to Detective supplemental report regarding the results of his investigation.

This concluded the investigation at the Ferguson Police Department.



She heard what sounded like a gunshot, so she went into the second floor apartment on the left. She then heard what sounded like 5 gunshots in rapid succession. When she looked outside, she saw a black male with shoulder length dreadlocks with blonde tips wearing a red T-shirt, gray pants, and colorful Nike shoes. She said he ran to the west on Canfield Drive from the scene.

was asked several times if she witnessed or saw the shooting. She said she did not. She said she went into the apartment after the first shot. She would not provide any information on the people she was with. She said after the shooting had stopped, she saw the Ferguson police vehicle parked in the street, where it remained during the interview, and the deceased male lying on the street.

At approximately 5:15 p.m., Ferguson Police Department vehicle was towed by Bolin Services from its location on Canfield Drive and was transported to the Saint Louis County Police Department Vehicle Processing Garage, located at 111 South Meramec Avenue, Clayton, Missouri 63105. Detective followed the vehicle from the scene to the Vehicle Processing Garage.

At approximately 5:27 p.m., Detective received another call from the Saint Louis County Police Department's Bureau of Communications who indicated another call was received from an unidentified male. The male indicated he witnessed the incident. The call came from a blocked number and was routed to Saint Louis County Police Department position T4. The male was still on the line and asked to be connected to a detective. Detective was then connected to the unidentified male, via a 3-way call.

The male on the phone call indicated the police officer acted in self-defense; however, the caller was unwilling to meet and discuss the incident further or properly identify himself.

Detective later requested and received a CD containing the phone call from the Saint Louis County Police Department's Bureau of Crimes Against Persons. This disc was identified as Tapes 3 and 4 and was later packaged as evidence and released to the Saint Louis County Property Control Unit.



At approximately 5:45 p.m., Detective was approached by a male who would not identify himself. The unidentified male indicated there was a male who was a witness to the incident standing with a group of individuals near the eastern end of the apartment complex.

As Detective and Detective were walking on Canfield Drive, outside the eastern end of the crime scene, attempting to locate the unknown witness, they walked by a parked vehicle occupied by an adult male and an adult female. The adult male in the driver's seat commented to detectives as they walked by that he witnessed the incident and the officer was, "in the right" and "did what he had to do." He added the statements being made by bystanders in the complex were inaccurate. The detectives momentarily stopped to speak with the male who was clearly uncomfortable speaking with detectives. The male indicated he was not making any further comments or identifying himself.

At approximately 11:11 p.m., Detective and Detective drove to the Ferguson Market, located at 9101 West Florissant Avenue in Saint Louis, Missouri 63136. They were assisted by Police Officer and Police Officer both of the Saint Louis County Police Department's Division of Patrol, assigned to the City of Jennings Detail. After arriving, detectives made contact with the evening manager of the business:

Detectives asked if the business was equipped with video surveillance cameras. He stated it was. He led detectives to the back room of the business, where the video surveillance equipment was located. already knew the specific time and camera angles detectives were interested in, as he was aware of the incident that occurred in the store earlier that day. He immediately accessed footage from 08/09/2014 at 11:53 a.m. He directed the detectives' attention specifically to the footage from Camera #6, which faces from the front door of the business toward the front counter, and Camera #7, which faces from the back wall of the business toward the front doors.

Detective and Detective observed the footage which did not contain audio. According to the timestamp on the video, at approximately 11:53 a.m., two subjects entered the store. Detectives recognized one subject as Michael Brown. He was large in stature and dressed in a red Cardinals baseball cap, white T-shirt, khaki shorts, tall yellow socks, and sandals. The second subject was much shorter and thinner. He had shoulder length dreadlocks and was wearing a black T-shirt and shorts. This individual was later identified as Dorian Johnson. Although detectives did not know Johnson at the time, for clarity purposes, he will be identified as Johnson throughout the description of the video.

In the video, Brown walked directly to the front counter and reached behind the counter, out of view. He pulled his hand back and was holding what employees later identified as a box of cigarillos. He handed the item to Johnson and reached a second time behind the counter. He pulled an additional item out, which employees later identified as a smaller packet of cigarillos. In doing so, it appeared as if Brown got into a verbal dispute with the employee behind the counter. At that time, Johnson reached around Brown and placed the first box back on the counter. The employee stepped around the counter. The verbal dispute appeared to continue between the employee and Brown. The employee stood in the path of Brown and Johnson at the front doors of the business. Brown approached the employee and shoved him to the side,

causing him to stumble into a nearby shelf of products. Brown and Johnson then exited the business at approximately 11:54 a.m., with Brown still in possession of the second item taken from behind the counter. identified the employee assaulted in the video as: also identified as the owner of the business. was accompanied in the store at the time by who was also the store's typical morning manager: identified the first item as a 60 count, box of Swisher Sweet brand cigarillos, regular flavor, valued at approximately \$33.99. He identified the second item as a 15 count, packet of Swisher Sweet brand cigarillos, regular flavor, valued at approximately \$15.00. The first item which appeared to be placed back on the counter by Johnson, was recovered from inside the store. was able to transfer the video surveillance footage of the incident to a USB memory drive. He included three additional outdoor views of the perimeter. Detective asked if was injured in any way during the robbery. did not believe so. could add nothing further and the interview was concluded. Detective Detective P.O. , and P.O. departed the business. drove to the Ferguson Police Department. After arriving, they made Detective and Detective contact with Captain Administrative Commander of the Ferguson Police Department. They

advised him of the facts and circumstances of the incident at the Ferguson Market. Captain

advised

them the Ferguson Market incident was previously documented under Ferguson Police Department Report Number 14-12388.

The video surveillance footage was downloaded and burned to a CD, which Detective later packaged and marked as evidence and released to the Saint Louis County Property Control Unit.

During the late evening hours of Saturday, August 9, 2014, Detective viewed online video footage from a local media outlet which showed an interview of a male who identified himself as Dorian Johnson. Johnson claimed he was with Brown when the incident took place. A computer search of Dorian Johnson was conducted which tentatively identified him as:

Dorian J. Johnson Black Male

The following information documents the Saint Louis County Police Department's investigative activities on Sunday, August 10, 2014.

At approximately 7:40 a.m., Detective attended the post-mortem examination of Brown at the Saint Louis County Medical Examiner's Office, located at 6039 Helen Avenue in Berkeley, Missouri 63134. Doctor performed the examination.

Detective and Detective were present for the post-mortem examination and conducted their investigation. See Detective supplemental report for additional details.

Before the examination began, Detective observed Brown lying on his back on an examination table. He was wearing a gray short sleeve T-shirt, khaki shorts with a black belt over blue underwear and yellow socks with the outline of marijuana leaves on them. He had brown paper bags covering his hands and an identification bracelet on his ankle.

Brown had the tattoo "Big Mike" on his right forearm, "Dre" on his left forearm, and "Kelle" on his upper right arm.

During the external examination, Doctor noted injuries consistent with gunshot wounds to the following areas on Brown's body:

Top of head
Forehead
Right side of chest
Right side of chest near the armpit

Through and through upper right arm
Through and through right forearm
Graze/Abrasion upper right arm
Right interior thumb

Doctor said the injury to the right thumb had a dark discoloration in and around the injury.

Brown had abrasions to the following locations:

Inside left forearm
Right hip
Left thumb
Left wrist

Right front shoulder

Forehead Bottom lip

Doctor said Brown had damage caused by a bullet to his right eye and what looked like an exit wound on his right facial cheek.

During the internal examination, Doctor removed one bullet from Brown's head, one from his right lateral back, and one from his posterior right chest.

Detective seized the bullets, fingernail scrapings/clippings from Brown's left and right hands, swabs from left and right hands, a blood card, clothes, and brown paper bags.

Detective also seized a small baggie containing a green vegetative substance believed to be marijuana from Morgue Attendant advised it was discovered during an inventory of Brown's clothes prior to the examination beginning.

The post-mortem examination concluded at approximately 11:10 a.m.

Detective conducted a manual check of the computer's software to ensure that the video surveillance software and footage was in fact being stored on the computer's hard drive. During this check, Detective observed a username and password was needed to access the DVR software. A store employee provided Detective with the username and password.

Detective seized and photographed the computer. Detective later took custody of the computer at the Saint Louis County Police Department's Computer Forensics Lab.

Detective took several photographs of the computer prior to disassembling it for examination.

Detective removed a Western Digital (500 Gigabyte) internal hard drive from the computer.

Detective connected the hard drive to a Tableau Forensic Duplicator (TD2) and extracted a forensic image of the hard drive to a computer lab hard drive that had previously been wiped to ensure no data was present.

Detective created two additional forensic images of the computer hard drive for examination purposes. The original hard drive discovered in the computer was seized as evidence to ensure the original data was not disturbed. One forensic image was seized as evidence.

Due to the specific DVR (digital video recorder) being utilized by the Ferguson Market, Detective inserted one of the hard drives containing a forensic image of the computer to enable his examination. Detective then powered on the computer and observed that the computer successfully completed the boot process. Detective then activated the "Dvis DVR" software and discovered it successfully loaded the video surveillance contained on the computer hard drive.

Detective extracted two sets of surveillance footage to DVD discs.

The first set of surveillance footage was from August 9th, 2014, shortly after 1:00 A.M. A copy of this was seized and packaged as evidence.

The second set of surveillance footage was from August 9th, 2014 after 11:00 A.M. A copy of this was seized and packaged as evidence.

At the completion of the forensic examination, Detective packaged the computer as evidence.

During the afternoon hours, Detective met with 911 Coordinator of the Saint Louis County Police Department Emergency Communications Network. indicated phone number which had previously been identified with an anonymous caller who called in on August 9, 2014, was actually an internal routing number belonging to the Saint Louis County Police Department's position T4. The actual originating phone number associated with the anonymous caller was

A computer record check of revealed the provider was Sprint Nextel. A Grand Jury subpoena, which was authored by Detective was delivered to the Saint Louis County Prosecuting Attorney's Office, requesting the subscriber information associated with this phone number.

The following information documents the Saint Louis County Police Department's investigative activities on Saturday, August 16, 2014.

During the morning hours of Saturday, August 16, 2014, the Federal Bureau of Investigation conducted a canvass of the Canfield Green Apartment Complex in an attempt to locate additional witnesses to the incident in question. The associated Federal Bureau of Investigation FD-302s and digital recordings can be referenced for additional information regarding the canvass.



At the front entrance to the building, detectives were contacted by and appeared uncomfortable by the media presence, immediately departed the conversation and sat inside vehicle on the parking lot. explained to detectives that did not wish to provide a statement at that time because there had been death threats about the situation. explained would only provide a witness statement if was compelled to by a Grand Jury.

This concluded the conversation with and departed the parking lot.

Each of these organizations had previously been identified as having provided witness coverage of the incident.

The individual. had engaged in a Instant Message (IM) chat with in which he described his alleged eyewitness account of the incident. An unknown individual, identified with posted a screenshot of this IM chat and posted it to a the Twitter handle of feed for witnesses. A subsequent computer investigation revealed was the same individual who Notification of this appeared to be the account holder of the account for information, including a digital copy of the information, was made by Detective to Detective

Detective was advised by Detective that information was being circulated regarding P.O. Darren Wilson's Facebook page. The information claimed P.O. Darren Wilson had uploaded details of the incident to his Facebook page. P.O. Darren Wilson had previously provided Detective with voluntary

written consent for his Facebook account to be accessed and searched. Detective relayed this information to Detective who accessed the account, digitally recorded the account's contents, produced a digital copy of the account's contents, and packaged this digital copy of P.O. Darren Wilson's Facebook account, which she placed into evidence at the Saint Louis County Property Control Unit. P.O. Darren Wilson's Facebook account displayed a Profile Name of "Darren Wilson" and a username of Detective also prepared a search warrant for the Facebook account of Darren Wilson, which was presented to and granted by Judge of Division of the Circuit Court of Saint Louis County. Detective prepared a search warrant for the five following Facebook accounts of: Detective of the Circuit Court of Saint The search warrant was presented to and granted by Judge of Division Louis County. Detective

Detective prepared a court order for Telecommunications for the wireless/cellular account of Darren Wilson, mobile phone number which was presented to and granted by Judge of Division of the Circuit Court of Saint Louis County. Detective subsequently executed the court order by sending it to on August 20, 2014, for which he received faxed communication of the court order's successful transmission.

Detective prepared a court order for Telecommunications for the wireless/cellular account of Darren Wilson, mobile phone number which was presented to and granted by Judge of Division of the Circuit Court of Saint Louis County. Detective subsequently executed the court order by sending it to Sprint on August 20, 2014.

At approximately 4:30 p.m., Detective contacted Paramedic by phone and asked him if he had any contact with P.O. Darren Wilson on scene or afterwards. This was based on a comment made by Lieutenant Colonel during his interview, in which he thought a Christian Hospital EMS Paramedic washed the blood off P.O. Darren Wilson's hands and arms. Paramedic said he and his partner,

Paramedic were dispatched to the scene on Canfield Drive. When they arrived, P.O. Darren Wilson was not at the scene, and they proceeded to a staging area.

This concluded the conversation with Paramedic

At approximately 4:35 p.m., Detective contacted Paramedic of Christian Hospital EMS by phone. He said he and his partner, Paramedic were operating Christian Hospital Ambulance on August 9, 2014. They were requested to respond to the Ferguson Police Department and check on P.O. Darren Wilson. When they arrived, P.O. Darren Wilson was in a room with another officer. P.O. Darren Wilson told them he was refusing medical treatment. said he and left the Police Department. He said they had no physical contact with P.O. Darren Wilson.

This concluded the conversation with Paramedic

At approximately 5:00 p.m., Detective contacted Paramedic by phone. He said after they left the sick case at Glenark Drive, they were flagged down by an officer on Canfield Drive to assist the shooting victim. He said he did not see P.O. Darren Wilson at the scene.

This concluded the conversation with Paramedic

After contacting all three sets of paramedics who had involvement with this incident, it was determined none of them assisted P.O. Darren Wilson in washing the blood off his hand and arms.

Detective received the Post-Mortem Examination Report of Brown from the Saint Louis County Medical Examiner's Office. The report, completed by Doctor indicated the cause of death was due to gunshot wounds of the head and chest, and the manner of death was homicide. Also attached was a Saint Louis University Toxicology Laboratory Report which indicated Brown tested positive for cannabinoids. Details of both the examination and the toxicology report can be viewed under Saint Louis County Medical Examiner's Office Report Number 14-5143.





At approximately 9:00 a.m., Detective Sergeant and Detective observed a follow-up interview with P.O. Darren Wilso, which was conducted at the Saint Louis Division of the Federal Bureau of Investigation. The interview was conducted by Special Agent AUSA and DOJ

Detective Sergeant and Detective observed the interview in a separate room via a closed circuit television system.

For details of the interview, the associated Federal Bureau of Investigation FD-302 can be viewed.

At approximately 10:00 a.m., Detective drove to the Ferguson Police Department and contacted Sergeant of the Ferguson Police Department. Sergeant provided Detective with four DVDs containing Ferguson Police Department radio traffic from August 9, 2014. Detective later packaged and marked as evidence the DVDs and released them to the Saint Louis County Property Control Unit.

Detective later reviewed a copy of the DVD for content. Detective discovered the first DVD contained tracks 323-454, the second DVD contained tracks 455-582, the third DVD contained tracks 583-719 and the fourth DVD contained tracks 720-870.

In the event there is a discrepancy between the audio recording and the transcript; reference should be made to the seized CD-R containing the audio recordings. For the contents of tracks 323 through 342 and 386 through 870, the associated CD containing the audio recordings should be referenced.

During a review of the audio, it was discovered several of the times associated with the audio tracks appeared to be incorrect. Specifically, on the CD provided by the Ferguson Police Department, audio track 386 with an associated time of 12:26:57, documented the Ferguson Police Department's request for assistance with crowd control. This radio traffic was communicated to the Saint Louis County Police Department via the Point-To-Point radio channel. According to audio from the Saint Louis County Police Department's Bureau of Communications, the same transmission started at 12:07:20. Based on these times, it appeared the time associated with the Ferguson Police Department's radio system was running approximately 19 minutes and 37 seconds fast.

Detective later spoke by phone with Sergeant and Disptacher of the Ferugson Police Department.

Sergeant and Dispatcher both confirmed there was a known issue wiith the radio system and it was in fact fast. They confirmed 19 minutes and 37 seconds would be a realistic time the system would be fast.

Detective also discussed with Sergeant and Dispatcher the Ferguson Police Department's Computer Automated Dispatching (CAD) system, which they referred to as ITI. Sergeant and Dispatcher indicated the CAD system maintained an accurate time.

According to the Ferguson Police Department's CAD system, Event Report Number 2014-029062, was opened after P.O. Darren Wilson initially called out on Canfield Drive. This event was documented on audio track number 369. This event was opened in the CAD system at 12:01:50 according to the Event Report timestamp. Based on the time of 12:01:50 associated with the creation of the Event Report and the time of 12:21:05 associated with audio track 369, it appeared the time associated with the Ferguson Police Department's radio system was running approximately 19 minutes and 15 seconds fast.

Detective also discussed with Sergeant and Dispatcher the 911 system. They each indicated the 911 system time can drift and therefore be inaccurate. They reiterated the times on the Event Reports would be the accurate times.

During the course of a several day period which concluded on August 28, 2014, Detective and Detective of the Saint Louis County Police Department's Division of Criminal Investigation, reviewed copies of previously seized security camera footage from various businesses located in Ferguson, Missouri. The footage review was in an effort to locate any possible pertinent information related to the investigation.

Although it cannot be said with certainty, the individuals noted with the below timestamps appeared to match the description of Dorian Johnson and/or Michael Brown.

The subject, a heavy-set male wearing a red baseball hat, white t-shirt, black backpack, tan shorts and white shoes, walks to the refrigerated section and appears to select several items. He approaches the counter, where he appears to put the items on the counter and have a conversation with the two employees behind the counter. At one point, he pulls an item out of his pocket and tosses it onto the counter. One of the employees picks the item up, examines it and places back on the counter. The individual in the red baseball hat then takes a white plastic bag off of the counter, starts to walk away, returns to the counter, leaves the bag and exits the business.

Timestamp 1:16 a.m. – The subject exits the business and returns to the vehicle. He enters the vehicle, and the vehicle leaves the lot.

Camera 11 was pointed toward Canfield Drive and captured pedestrian and vehicle traffic along Canfield Drive near West Florissant Avenue. Camera 2 was pointed toward the intersection of West Florissant Avenue and Canfield Drive and captured pedestrian and vehicle traffic in and around this intersection. Camera 9 pointed south toward West Florissant Avenue and captured pedestrian and vehicle traffic along West Florissant Avenue.

The disc contained nine still images consistent with the description of Michael Brown and Dorian Johnson. The disc also contained camera footage of both Brown and Johnson exiting the store, which can be summarized as follows:

Still images 1-3, date and time stamp (8/9/2014, 11:52:56 a.m.), Brown and Johnson approaching the front door of the business

Still images 4-5, date and time stamp (8/9/2014, 11:54:01 a.m.), Brown and Johnson exiting the business, Johnson briefly stops and faces an unknown male before continuing away from the business

Still images 6-9, Brown and Johnson walking east into the parking lot out of view

The moving footage captured from the camera depicts an apparent white Chevrolet, Monte Carlo, with front end damage, operated by an unknown black male. Based on the footage, the male enters the business just prior to Brown and Johnson and exited within seconds prior to Brown and Johnson. This male did not appear to be with Brown and Johnson; he appeared to be a customer who most likely witnessed the events that occurred inside. The white Monte Carlo leaves the parking lot at approximately 11:54:28.

In addition, a male employee of the business could be seen exiting the business at approximately 11:54:14 a.m.

Nothing further of immediate evidentiary value was identified from this footage.

A disc labeled Cam 02 parking lot, identified as footage from an exterior CCTV camera, capturing an alternate angle of the apparent front parking lot of the Ferguson Market was reviewed.

This disc contained 11 still images and moving footage consistent with the above summary of Cam 01.

Nothing further of immediate evidentiary value was identified from this footage.

A disc labeled Cam 03 side lot, identified as footage from an exterior CCTV camera, capturing an alternate angle of the apparent side parking lot of the Ferguson Market was reviewed.

The disc contained one file of moving footage of the side parking lot.

Nothing of immediate evidentiary value was identified from this footage.

A disc labeled Cam 06 front door, identified as footage from an interior CCTV camera, capturing the apparent interior front entrance and entry way of the Ferguson Market was reviewed.

A disc labeled Cam 07 register, identified as footage from an interior CCTV camera, capturing the apparent interior register area of the Ferguson Market, was reviewed.

Two discs labeled "Ferguson Market 1A" and "Ferguson Market 1B", identified as footage from all interior and exterior CCTV cameras, capturing all cameras of the Ferguson Market, were reviewed.

Disc 1A contained all of the recorded footage from the market in the early morning hours prior to the incident.

Detective reviewed footage which contained five camera views of the store with a date and timestamp of 8/9/2014 between the hours of 1:06 a.m. -1:23 a.m.

Camera 1 depicted a moving view of the front parking lot.

At approximately 1:13:28 a.m., a male arrived as a backseat passenger in a dark colored passenger vehicle. The camera view eventually captured his exit from the store at approximately 1:16:35.

Camera 2 depicted the same footage as the Camera 1 view from a different angle of the parking lot.

Camera 6 depicted the front entrance and entry of the business interior. Brown enters and exits the front doors as reported on Camera 1.

Camera 7 depicted the store interior to include the rear drink cooler and register from the customer side. The male proceeds to the beverage cooler, selected unknown items and proceeded to the register. The male remains at the counter and eventually leaves the area of the registers with no merchandise. The male departed the store at approximately 1:16:35 a.m.

Camera 11 depicted a male from a vantage point behind the registers looking out toward the customer.

Disc 1B contained all pertinent footage captured as described above involving the incident while two males were inside and outside of the Ferguson Market.

This disc appeared to contain all footage described on the previously reviewed Ferguson Market discs.

Upon accessing this URL, Detective downloaded and digitally saved the six hour podcast video titled, "Police Brutality! What Should Citizens Do In Response To A Growing Trend" (2 parts). She subsequently produced a digital copy of this video which she marked, packaged, and placed into evidence and released to the Saint Louis County Property Control Unit.

The area of concentration within the video in question was available on the CD, under the file identified as "Part 2". The pertinent interview began at an approximate time of twelve minutes and thirty seconds and continued through an approximate time of twenty-four minutes and fifty seconds.


