Dear Mr. Hulse:

Thank you for your e-mail of June 14, 2012, to the Department of Agriculture's (USDA) Meat and Poultry Hotline inquiring about the operation of horse slaughter facilities in the United States. The Food Safety and Inspection Service (FSIS) has been asked to provide you with a response, and I appreciate the opportunity to address your concerns.

FSIS is the public health regulatory agency in USDA responsible for ensuring that meat, poultry, and processed egg products are safe, wholesome, and accurately labeled. FSIS enforces the Federal Meat Inspection Act, the Poultry Products Inspection Act, and the Egg Products Inspection Act, which require Federal inspection and regulation of meat, poultry, and processed egg products prepared for distribution in commerce for use as human food. FSIS also is responsible for enforcing the Humane Methods of Slaughter Act, which requires that all livestock at federally inspected establishments be handled and slaughtered in a humane way. Humane methods of handling and slaughtering livestock prevent needless suffering of animals.

Currently there are no facilities approved for horse slaughter in the United States.

Following a decision by Congress in November 2011 to lift the ban on horse slaughter, two establishments, one located in New Mexico and one in Missouri, have applied for a grant of inspection exclusively for equine slaughter. FSIS is currently reviewing those applications.


However, given that the agency last conducted a horse inspection 6 years ago, FSIS has determined that despite the congressional decision to lift the ban, the agency will require a significant amount of time to update its testing and inspection processes and methods before it is fully able to develop a future inspection regimen.

FSIS is responsible for carrying out and enforcing the food safety laws that Congress writes. FSIS does not introduce bills or write statutory laws. As only Congress can change the laws, you may wish to bring your concerns to the attention of your elected representatives.
