Good Morning Dr. Gilmore,

I made another visit to Responsible Transportation on Friday, June 7th. The equipment is in place and the construction on the kill floor is complete with the exception of some plumbing associated with sinks and electrical work on some of the equipment. I am working with them to establish their hours of operation. We discussed 9 CFR 325.11 at length as plant management will be applying for a permit to transport undenatured inedible product to a zoo food producer. Appropriate paperwork was completed and the order submitted for the establishment's official brand. Deep cleaning of the facility and finishing touches are to begin early this week. The final walk through, however, has been moved to next week at plant management's request. I will advise you when a specific date has been established.
