It has been several years since FSIS has last oversaw the slaughter of equines. OPHS is currently developing and validating up-dated drug residue methodologies, and until that work has been completed, no grant of inspection will be issued. We will work with the plant on assessing food safety programs and gathering information for the NEPA assessment, and can do a final walk through to determine that all SPS issues have been addressed.
