

The only designated wild and scenic river in Missouri is the Eleven Points River. The Grand River is a little over 1.5 miles south of Rains Natural Meats. The City of Gallatin, MO has agreed to accept effluent from the plant. Rains will use

be the city sewage system. The parties are familiar with this agreement as they used it prior to the plant implementing its now unlicensed lagoon system. The blood and offal contents will be caught in inedible barrels and sent to rendering. The only thing that enters the discharge water from slaughter is the carcass wash and sanitation effluent, and any incidental offal content spillage that occurs.
