OGC reported today that, in the lawsuit by FRER, HSUS, et al. against the Department, the plaintiffs and intervenors for the plaintiffs responded yesterday to the Department's August 26 motion to consolidate the Preliminary Injunction hearing and briefings on the merits in order to expedite resolution of the case. The plaintiffs supported the Department's motion, but they asked the Court first to address their motion to terminate the security bonds protecting the interests of Valley Meat, Roswell, NM, and Responsible Transportation, Sigourney, IA.

OFO reported yesterday that Mr. David Rains, vice president of Rains Natural Meats, Gallatin, MO, had stated that he was planning to submit information supporting his request for a grant of inspection for equine slaughter next Tuesday, September 3, and that he intended to begin operations as soon as possible after obtaining the grant. OFO also reported that APHIS would be sending a representative to the establishment as early as this weekend to check on the adequacy of holding pens at Mr. Rains' facility.

Mr. Rains has arranged to catch

effluent from his establishment in holding tanks that would be emptied into the Gallatin municipal sewage system.)
